SUBJECT:	FY 2022 Operating Budget Instructions	
DATE:	July 13, 2021	

The Board of Supervisors will consider and act on the University's proposed FY 2022 operating budget at its meeting on September 10, 2021. Executive Vice President Donna Torres will summarize the significant issues in the budget in a presentation to the Board of Supervisors. The printed FY 2022 operating budget will again consist of the budget forms issued by the Board of Regents. All budget materials (BOR Forms) will be due in electronic format via an email to me at <u>jburas@lsu.edu</u> no later than Friday, August 13, 2021. The resubmission of the BOR forms with the FY 2021 actual data and the OPB forms (Operational Plan, Addenda, etc.) will be due to me on Friday, September 3, 2021 to allow time to comply with the Board of Regents' deadline of September 27, 2021.

#### FY 2022 Operating Budget

The letters, instructions, and forms needed to complete the FY 2021-2022 Budget Submission Process were emailed under <u>separate cover</u> on July 7, 2021. All of these documents are posted on the Finance and Facilities section on the Board of Regents <u>website</u>.

• **Budget Forms** - please ensure that you use the <u>current</u> BOR budget forms that were emailed July 7, 2021, and also available on the Board of Regents <u>website</u>.

FY 2022 Appropriation Letters received from the Office of Planning & Budget were emailed July 6, 2021, under <u>separate cover</u>.

The Health Care Services Division, and Pennington Biomedical Research Center should submit BOR-1, BOR-2, BOR-3 and BOR-3A for their FY 2022 operating budgets by Friday, August 13, 2021 and the Division of Administration's budget forms (if applicable) for these units should be submitted to us by Friday, September 3, 2021.

#### FY 2022 Priorities

Please provide by **Friday, August 13, 2021**, a narrative outlining your campus' top budget priorities for FY 2022.

#### **Maximum Support for Athletics**

Although the University does not allow its entities to use state funds to subsidize athletics, the amount of maximum state support for FY 2022 pursuant to the Board of Regents policy was emailed July 7, 2021, under <u>separate cover</u>.

## FY 2022 LSU Institution Charge

The institutions should budget the appropriate institution allocation charge. Final FY 2022 institutional charges are pending review and approval by President Tate. The preliminary charges below are calculated using the same general methodology in which it was calculated last year. For all campuses, the preliminary charges this year are 15 basis points based on the campus's actual FY 2020 revenue. Any necessary changes to these amounts based on the build-out of President Tate's leadership team will be communicated once President Tate has approved.

#### FY 2022 Health Care Policy Reimbursement

LSU Health New Orleans and LSU Health Shreveport fund equally (50/50) the LSU Health Care Policy restricted fund program expenditures. Like the University cost allocation process for the Institution Charge and Internal Auditor Reimbursement, the health science centers will be charged semi-annually for actual expenditures as of December 31, 2021, and June 30, 2022.
