# FY 2025 Operating Budget

The Board of Supervisors will consider and act on the University's proposed FY 2025 operating budget at its September 2024 meeting. Executive Vice President Kimberly Lewis will present significant budget topics during the meeting. The printed FY 2025 operating budget will again consist of the budget forms issued by the Board of Regents. The letters, instructions, and forms needed to complete the FY 2024-2025 budget submission process are forthcoming. All budget materials (resubmission of BOR forms with FY2024 actual data and OPB forms (Operational Plan, Addenda, etc) will be due in electronic format via email to me at <u>brobert1@lsu.edu</u>. Due dates and forms will be sent once that request is made by Board of Regents. Please ensure that you use the <u>current</u> BOR budget forms that will be emailed and available on the Board of Regents <u>website</u>.

The Board of Regents will hold its FY 2025 operating budget hearings September 24, 2024.

# FY 2025 Health Care Policy Reimbursement

LSU Health New Orleans and LSU Health Shreveport fund equally (50/50) the LSU Health Care Policy restricted fund program expenditures outlined in the MOU. LSU Health New Orleans, LSU Health Shreveport, and Pennington Biomedical Research Center will fund equally costs related to the salary and benefits of the Vice President of Health Affairs and Chief Health Officer. These reimbursements will be charged semi-annually for actual expenditures as of December 31, 2024, and June 30, 2025.
